

## CONSULTANCY FOR DEVELOPMENT OF MONITORING AND EVALUATION FRAMEWORK FOR SOCIAL PROTECTION PROGRAMS

## 1. Background

The National Social Protection Agency (NSPA) is by an executive order mandated under the National Social Health Insurance Act (15/2011) to administer and implement social protection programs identified by the government of Maldives. Additionally, NSPA is the responsible agency to regulate and conduct Social Protection Programs under the Social Protection Act (2/2014) and the Disability Allowance program under the Disability Act (8/2010).

The Government's Strategic Action Plan (2019-2023) aims to establish a monitoring and evaluation framework for all social assistance programs (Action 3.3d). NSPA as the lead implementing agency is seeking a Monitoring and Evaluation expert to design and develop a monitoring and evaluation framework to compliment and strengthen the monitoring of social protection programs.

## 2. Objective

Creation of a sustainable monitoring and evaluation framework that enables collection of reliable, precise and timely information and data for measuring and reporting of social protection program outcomes.

#### 3. Responsibilities with Deliverables and Timeline

The Consultant will be responsible for developing and establishing a monitoring and evaluation framework. The Consultant shall report to the focal point assigned by the Agency. The proposed schedule for the deliverables of the consultant is as follows:
