CONSULTANCY FOR CONDUCTING TRAINING PROGRAMME FOR STAKEHOLDERS ON THE CLASSIFICATION OF PERSONS WITH DISABILITES IN MALDIVES

1. Background

The Disability Allowance program was introduced under the Disability Act (8/2010) with the objective of protecting the rights of Persons with Disabilities (PWDs) and to enable them to have equal opportunities in society as others. The Disability Act mandates a monthly allowance of MVR 2,000 to be provided to registered Persons with Disabilities.

The Regulation 2021/R-54 on Identification of Persons with Disabilities and Maintenance of Registry of Persons with Disabilities, published on 14th April 2021 provides the guideline to evaluate, classify and determine Persons with Disabilities, to enable the establishment of a National Registry of Persons with Disabilities in Maldives.

2. Objective

The objective of this Consultancy is to design and carry out a training program for relevant stakeholders on the newly published guidelines to evaluate, classify and determine Persons with Disabilities as per the Regulation 2021/R-54, and other existing laws and regulations.

3. Responsibilities of the Consultant and Expected Deliverables

The Consultant will be responsible to design and conduct the training program for key stakeholders on the identification and classification of Persons with Disabilities. The indicative work plan and key deliverables are as follows:
